### **Services offered:**

### Call a Lawyer when Detained at Police Office

Legal Aid offers a free 24 hour service to anyone accused of an offence (ie., no eligibility criteria) to consult with a lawyer on short notice while they are detained in custody.

# **Duty Counsel**

For certain criminal matters, you may be able to get advice from Duty Counsel at the court house. Duty Counsel can explain the court process and give you informal advice about making a plea, asking for an adjournment, and appearing at a bail hearing or at sentencing. There is no financial eligibility criteria and no cost to access duty counsel services at the courthouse.

Legal Aid also provides duty counsel services for the following specialized courts including Mental Health Docket, Mental health Review Board, Domestic Violence Court, and Elsipogtog Healing to Wellness Court.

### **Criminal Trial Services**

If you have been charged with a criminal offence and you cannot afford a lawyer, you may apply for legal aid.

### Family Duty Counsel

Respondents can access Duty Counsel for certain family law matters right at the courthouse or can contact their local office. There is no financial eligibility criteria and no cost to access duty counsel.

# Family Legal Aid

If you meet financial eligibility criteria you may receive a certificate to have a lawyer assist you with the following family law matters: child protection proceedings, child support, parenting order, spousal support, divorce, Emergency Protection Orders pursuant to the *Family Homes on Reserves and Matrimonial Interests or Rights Act*, and Emergency Intervention Orders pursuant to *Intimate Partner Violence Intervention Act*.

# Family Law Workshops for self-represented Litigants

Provided around the province each month these workshops cover topics such as doing your own divorce, changing child support and going to family court. They help prepare you for navigating the court system on your own.

### Family Advice Lawyer

Family advice lawyers are available to provide free general legal information for up to two hours on family law matters. They can explain what to expect from the court process and help you understand court forms. If you do not live in a region with a FLIC, you can contact the family advice lawyers. To get an appointment with a family advice lawyer in your area, call toll free: 1-855-266-0266.

## Family Law Information Centre (FLIC)

There are two Family Law Information Centre, one at the Moncton law courts and one at the Saint John courts. They serve only their judicial districts. They offer information and resources about family law issues, referrals to other services and help connect the public with the family advice lawyer.

## Court-Ordered Evaluations Support Program (C-OESP)
