The Workers' Advisers Program offers legal services to injured workers who have been denied Workers' Compensation Board Benefits.

Services are offered at all levels of appeals, including at Court in special cases. In general, in order to qualify for services, an injured worker must have reasonable expectation of success in obtaining at least \$500, or the equivalent, in an appeal from a Workers' Compensation Board and the Workers' Compensation Appeals Tribunal. Clients of the program are in a solicitor/client relationship with the program and its staff, in the same way as they would be with any other lawyer or law firm in Nova Scotia.

The Nova Scotia Legal Aid Commission delivers legal aid via a network of 16 community-based law offices as well as 3 sub-offices. Every regional office deals with Family Law, Criminal Law, Civil Law and social justice issues. Legal Aid Lawyers are seen as experts in their areas of law and "Here to Help" is their motto. There are financial eligibility guidelines for full service (this means a lawyer for your case), but discretion can be applied.

Free Brief Legal Advice at Family Courts

The Nova Scotia Legal Aid Summary Advice lawyers at Family Courts across Nova Scotia helps people who need legal advice on a family law matter, but who do not have a lawyer. The Summary Advice lawyer provides basic legal advice, free of charge, regardless of how much you make or where you get your income. Summary Advice Counsel lawyers do not go to court with people.

You can get basic legal information and advice about how to start or respond to a Family Court Application, help with legal documentation for Family Court, advice on consequences of agreeing or not agreeing to a court order, other aspects of Family Law, including if you are considering possible future Family Law issues and would like some advice. Your case or issue must be somehow related to the court where the Summary Advice lawyer is located. For example, if you are applying to the court in Halifax, you should book an appointment with the lawyer in Halifax.

Legal Clinics

The Office also provides free Legal Clinics around Nova Scotia. Legal Clinics provide seminars and advice around a certain legal topic, for example, "Form Filing". Court of Appeal Summary Advice

NSLA provides Summary Advice Counsel to dispense summary advice (quick and limited legal advice) at the Court of Appeal. Check the Legal Aid Calendar to see when events take place.

Legal Outreach

NS Legal Aid provides outreach clinics, where Lawyers go to communities and provide free legal advice on your family law or social justice issue. The Nova Scotia Legislature allows members of the public to visit the law library and use the collection during regular daytime hours. Library materials may be borrowed through interlibrary loan, with some exceptions: reference books, legislative materials, and fragile texts may only be used in-house. Loans are for two weeks. Staff assistance to the public may be limited depending on the activities of the House of Assembly.

reachability is a charitable organization that operates a Legal Referral Service for people with disabilities. Through this service, persons with a disability may receive a free one hour session for legal advice from a lawyer who volunteers with reachability. The reachability lawyer will not represent you for the whole court process. You will have to pay the lawyer after the first free appointment, unless you make special arrangements with the lawyer.

Free Legal Clinic

If you are going to the Supreme Court or Court of Appeal in the below listed cities without a lawyer the Free Legal Clinic may be able to help. The Clinic provides information and advice on civil law issues before the Supreme Court or the Court of Appeal. Family law issues, except child protection appeals, going before the Court of Appeal also qualify.

- The Clinic does not deal with criminal law issues in either Court, or family law issues in the Supreme Court Family Division.
- There is no income threshold to meet. Everyone qualifies for this free service, as long as your case meets the criteria above.
- You can make an appointment to meet with a volunteer lawyer and law student for a private, free 60 minute session. It is not a drop-in clinic, you must schedule an appointment to be seen.

LISNS provides a toll-free legal information line which is staffed by legally trained counsellors from 9:30 am to 5:00 pm (1:00-2:00 pm closed for lunch) through which there is access to a Lawyer Referral Service and Mediator Referral Service.

Lawyer Referral Service

You can contact the <u>Lawyer Referral Service</u> to get the name and contact information for a lawyer in your area. You then contact the lawyer to arrange for a 30-minute appointment. This appointment is \$20 + tax. If you decide to hire the lawyer after the initial appointment, and the lawyer agrees to represent you, you will need to discuss how much the lawyer will charge to represent you.

Halifax Regional Police Victim Services Help with Applying for a Peace Bond

Individuals who wish to apply for a peace bond through the Provincial Court in Halifax and Dartmouth can get support from Halifax Regional Police (HRP) Victim Services. Victim Services volunteers will provide potential and current applicants with information on the application process, assistance to complete the application forms and ongoing emotional support. Depending on your situation they may be able to offer a free initial telephone call or email consultation of up to 30 minutes, free or contingency-based representation, a fixed-fee or fee-for-service retainer and/or referrals to other legal professions.
